RE: ICMA Member Jane Mahony Howington City Manager, City of Hudson, Ohio

Dear Mr. Ott:

As residents of the City of Hudson, Ohio, we want to bring to your attention several concerns regarding City Manager Jane M. Howington, a member of ICMA, and her conduct in office.

On May 7, 2019, the City of Hudson conducted "an advisory vote" regarding a potential residential and commercial development project, known as Phase II, in downtown Hudson. A majority of voters rejected Phase II. Since that time, despite the clear wishes of the voters, Ms. Howington has continued to work on her vision of the Phase II development project in an effort to move it forward, ignoring voter sentiment.

This issue has divided our community for nearly two years and is still a point of contention. In an attempt to better understand the decision-making process regarding the Phase II development and to be fully informed about the status of the project, we and others in our community submitted requests to the City of Hudson for public records, including environmental reports and e-mail communications.

Upon reviewing these public records, we have several concerns about how Ms. Howington conducts city business, which include:

- 1. Allowing City staff to campaign for the Phase II development project using tax-payer funded resources
- 2. Supporting candidates for City Council¹
- 3. Limiting public input and engagement with residents
- 4. Actively finding ways to circumvent the State of Ohio's open meeting requirements for public bodies

The environment that Ms. Howington has created at Hudson City Hall appears to be one that is:

- 1. Dismissive of residents' concerns
- 2. Setting policy in private
- 3. Allowing political activity using taxpayer-funded resources.

Based on these public records and the subsequent conversations they have sparked among fellow residents and on social media platforms, we respectfully request that the ICMA Executive Board review this complaint and supporting exhibits, and open an Ethics Inquiry into Ms. Howington's conduct.

Specifically, we believe Ms. Howington has violated **Tenet 3** (Integrity and Public Confidence), **Tenet 4** (Serving the People's Interests), **Tenet 7** (Political Activity), and **Tenet 9** (Communication with Citizens) of the ICMA Code of Ethics, as follows:

Tenet 3. Demonstrate by word and action the highest standards of ethical conduct and integrity in all public, professional, and personal relationships in order that the member may merit the trust and respect of the elected and appointed officials, employees and the public.

Guidelines: <u>Public Confidence</u>. Members should conduct themselves so as to maintain public confidence in their position and profession, the integrity of their local government, and in their responsibility to uphold the public trust.

Tenet 4. Serve the best interests of the people.

Guidelines: <u>Inclusion</u>. To ensure that all the people within their jurisdiction have the ability to actively engaged with their local government, members should strive to eliminate barriers to public involvement in decisions, programs, and services.

Tenet 7. Refrain from all political activities which undermine public confidence in professional administrators. Refrain from participation in the election of the members of the employing legislative body.

Guidelines: <u>Elections of the Governing Body</u>. Members should maintain a reputation for serving equally and impartially all members of the governing body of the local government they serve, regardless of party. To this end they should not participate in an election campaign on behalf of or in opposition to candidates for the governing body.

Tenet 9. Keep the community informed on local government affairs; encourage communication between the citizens and all local government officers; emphasize friendly and courteous service to the public; and seek to improve the quality and image of public service.

Set forth on the following pages are the specific activities and communications that have caused great concern within our community and warrant a thorough review. We reference specific public records in the summary below and we are providing the public records in their entirety for your review.

TENET 3

In the time leading up to the May 2019 advisory vote on the Phase II development project referenced above, City Manager Howington and several members of her staff collaborated with, and actively participated in, the campaign to support a "Yes" vote. While we understand that City Administrations may provide information about issues that are put before the electorate, the efforts outlined here appear to clearly cross the line into campaigning. That campaign failed, 48% 'Yes' to 52% 'No', with a majority of voters casting ballots against the development project, backed by Ms. Howington. Despite this outcome, Ms. Howington engaged a crisis communications firm at taxpayer expense to help revive the Phase II project and convince voters to support it, ignoring thus ignoring their previous position on the matter.

1. In an e-mail, dated: June 7, 2019, Nora Jacobs of Hennes Communications e-mails City Communications Manger Jody Roberts to provide talking points designed to address resident concerns about the project they had already voted down, as well as "Concerns That Resident Input Is Being Ignored."

Additionally, these e-mails also provide a glimpse of Ms. Howington's negative and dismissive opinion of some Hudson residents, including the majority of voters who did not vote for Downtown Phase II.

2. In an e-mail, dated: July 8, 2019, Ms. Howington wrote to Nora Jacobs of Hennes Communications via email, which had the subject line:

"It appears our negative group is beginning their assault on council".

In the e-mail, she went on to refer to some Hudson residents as

"the anti-everything group"

This dismissive attitude towards residents is also expressed by city staff under Ms. Howington's supervision.

3. In an e-mail, dated: July 18, 2019, Communications Manager Jody Roberts states:

"I'm sure the anti-group hasn't given up"

The dismissive and disrespectful tone Ms. Howington took in these e-mails is also seen in e-mails in which she discusses current City Council Members and other elected officials. It appears that she has clearly established preferences for those elected officials that she supports and those that she doesn't.

4. In an e-mail, dated: October 20, 2019 to Jody Roberts, Ms. Howington writes:

"Maybe that's why [State Representative] Kristina [Roegner] is so involved with our local election! Can you imagine her as strong mayor and [Council Member] Beth [Bigham] as her chief of staff!!!"

After reading these e-mails, it appears Ms. Howington, through her use of dismissive and disrespectful language, is failing to uphold Tenet 3 (Integrity and Public Confidence) of the ICMA Code of Ethics.

TENET 7

Ms. Howington's tone is markedly different in the e-mails in which she appears to have actively supported candidates for Hudson City Council and shared that support using taxpayer-funded resources, specifically, via the City of Hudson e-mail system. Further, staff under her supervision, including Economic Development Director James "Jim" Stifler, appear to actively support candidates for City Council, also using taxpayer-funded resources.

The City of Hudson Handbook explicitly states that the City shall not use its resources "to influence the outcome of elections" for local ballot measures. Despite this, Hudson staff actively worked with the pro-Phase II political action committee (Citizens for an Informed Hudson), coordinating tasks, using city resources to help distribute pro-Phase II yard signs, and discussing the content of campaign literature. Economic Development Director Stifler used his taxpayer-funded city e-mail account to e-mail coworkers, who live in Hudson, to encourage them to vote for Phase II. All of these staff members are under the supervision of City Manager Howington and work at her direction.

1. In an e-mail, dated: March 18, 2019, staff members discuss content of a pro-Phase II video, providing content that arguably goes beyond information and crosses the line into campaigning with statements like:

"Downtown Phase II is an Economic Development imperative for the City of Hudson."

"We are a class A town without any class A office vacancy."

"This project will enhance the vibrancy of our downtown and ensure its viability for years to come. Downtown Phase II will be on the ballot as Issue 11 on May 7. This is your chance to have a say in Hudson."

2. On March 25, 2019, in response to seeing the "ad for Issue 11 that will appear in the Hub on April 21 and April 28", Howington writes:

"It needs a big word VOTE on MAY 7th!"

3. On April 8, 2019, City of Hudson Communications Manager Jody Roberts actively seeks information, and coordinates with a member of the pro-Phase II PAC, who is working to convince a resident to put a 'Vote Yes' yard sign on her property.

4. On April 18, 2019, Economic Development Director Jim Stifler writes to several coworkers who are also Hudson residents:

"On May 7, you can have your say in the future of Downtown Hudson."

5. On April 22, 2019, City of Hudson Communications Manager Jody Roberts coordinated, via city e-mail, with the pro-Phase II PAC to provide a 'Vote Yes' yard sign to a resident. She states:

"Glad to hear you want to put up a Vote Yes yard sign."

6. On May 3, 2019, Communications Manager Jody Roberts and Assistant City Manager Jeff Knoblauch discuss an "Anti Phase II Flyer" on their taxpayer-funded e-mail accounts, to which Roberts responds:

"Ridiculous misinformation campaign. All wrong stats."

7. On May 8, 2019, following the advisory vote which failed to produce support for the Phase II project, the head of the pro-Phase II PAC e-mails the PAC, members of Council and city staff to discuss the defeat and plan next steps.

Additionally, based on the public records we have received, it is clear that the political activity occurring at City Hall goes beyond supporting ballot measures. Ms. Howington, herself, has offered her support to candidates for City Council via the City's taxpayer-funded email system. Additionally, staff under her supervision have also supported candidate campaigns using the City's official taxpayer-funded e-mail system.

1. In an e-mail, dated: October 10, 2019, subject line RE: Meet the candidate party at my home for Nicole, Howington writes:

"Thanks for the invite and of course I am very supportive. I also have to be careful not to be involved in any one individuals [sic] campaign so I don't attend any of the sessions."

While Howington acknowledges that she has to be careful not be involved in a campaign, she nevertheless expresses support for a candidate, Nicole Davis, who was running against an incumbent member of Hudson City Council.

2. In an e-mail, dated: September 20, 2019, Howington proactively offered to attend a forum with Council Member Lisa Radigan, a candidate for re-election, despite her recognition that it would be outside normal protocol. In the e-mail, Ms. Howington stated:

"Staff doesn't generally go to forums during the campaign season but do you need me there?"

3. In an e-mail, dated: September 7, 2019, Economic Development Director Jim Stifler responds to a request from political consultant Nicole Kowalski to review and advise regarding campaign literature for City Council candidate Nicole Davis with:

"I will comment in next 48 hours. Lots of easy improvements."

4. In an e-mail, dated: June 24, 2019, Stifler arranges to meet with City Council candidate Kate Schlademan to provide her with information to support her campaign.

Individually, these e-mails may seem insignificant. Collectively, they illuminate a pattern of behavior and suggest a culture at City Hall that permits active campaigning by city staff for candidates and ballot measures. It appears there were frequent violations of the City's own policy regarding campaigning by staff which have gone unchecked by Ms. Howington. This has created an environment in which it seems that Ms. Howington, as City Manager, is working to implement her own vision – not that of the people of Hudson nor the Hudson City Council – of who should serve on City Council, and plans for the city's future. This type of behavior appears to violate Tenet 7 (Political Activity).

<u>TENET 9</u>

We do not take this allegation lightly. We believe it is further supported by the actions of Ms. Howington, in coordination with certain City Council Members, regarding a community survey that Hudson's Park Board was planning to issue to residents.

Throughout the summer and early fall of 2019, Hudson's Park Board was developing a survey to be issued to city residents regarding use of the city's parks. The results of the survey would be used by the Park Board to form recommendations to Hudson City Council. Ultimately, and to the disappointment of members of the Park Board, the version of the survey that was provided to the public was much narrower in scope than the Park Board (and others) had hoped. We believe Ms. Howington's action violate Tenet 9 (Communication with Citizens).

<u>TENETS 4 & 9</u>

It appears that Ms. Howington and some members of City Council decided to limit the scope and content of a community survey in a manner that allowed them to avoid public scrutiny and public comments and input as contemplated by Ohio's open meeting laws.

1. In an e-mail, dated: June 3, 2019, Assistant City Manager Frank J. Comeriato, Jr. reminded Ms. Howington that she wanted to discuss the Park Board survey in

"this Friday's morning [agenda planning] meeting".

2. In an e-mailed, dated: September 20, 2019, Ms. Howington describes the Friday morning meetings to then-Council Member Dennis Hanink:

"I believe all members of Council know there is a standing Friday morning meeting to review the agenda for the upcoming week before it gets published. I also believe members of Council know they can attend these sessions though we try to keep the attendance under a quorum." (emphasis added) Ms. Howington further writes that she uses these Friday morning meetings

"for input or suggestions on issues that may be coming up."

According to the <u>state of Ohio's open meeting laws</u>, if a majority of council members are present at a meeting to discuss the public's business, it must be open to the public and the public must be notified so that they can attend. Ms. Howington's efforts to limit attendance by council members by default limits the points of view that can be heard in the meetings, and limits the public's interaction with the City Council and those setting policy for the city.

In the instance of the Park Board survey, it appears that the Friday morning closed-door session in which the Park Board survey was discussed (without a quorum) resulted in limitations on the scope of the survey, as evidence by the directive issued to the members of the Park Board by Assistant City Manager Frank J. Comeriato, Jr.

3. In an e-mail, dated: September 20, 2019, Comeriato shared the direction he received from the City Manager and certain City Council members regarding the survey:

"First, the City Manager and City Council have asked and have been clear that we do not include survey questions pertaining to a potential Community Recreation Center."

Comeriato further writes:

"Second, as we are all aware, the initial draft of the survey included several questions regarding parks programming of which virtually none pertained to the City's current parks operations or offerings. Those types of questions will also be taken out of the survey."

Additional e-mails related to the Park Board survey demonstrate a concern, on behalf of both members of the Park Board and at least one member of City Council, about the decisionmaking process and the impact on the Park Board's ability to not only survey and engage residents, but also to provide well-researched recommendations to City Council.

4. In an e-mail, dated: August 24, 2019, then-Park Board Chairman Keith Smith wrote:

"Handcuffed again! While I appreciate the desire and need for an overall community survey, I'm growing weary of what I perceive as a decreasing amount of independence the Park Board has from Council. We have been tasked to be an advisory board in Parks yet council is consistently attempting to "steer" our process and thus becoming an influential factor in the opinion given by the board, whether we like it or not." 5. In an email, dated: September 20, 2019, then-City Council Member Alex Keleman, referencing this issue, wrote:

"It was the cabal setting the direction as you probably surmised. Only difference between this decision and others (moving the City manager vote, etc.) is here we have it in writing."

Based on these exchanges, it is clear that elected and appointed officials view Ms. Howington as going beyond her role as City Manager and an *advisor* to City Council. Her actions, especially those to regularly avoid a quorum, thereby allowing her to discuss city matters and make decisions in private, closed-door sessions, serve to undermine the public's trust in our local government. As demonstrated by these e-mails regarding the Park Board Survey and addressing the 'Friday morning meetings', it appears that Ms. Howington may be in violation of Tenet 9 (Communications with Residents) and Tenet 4 (Inclusion), given that both the discussions with Council Members absent a quorum and the direction regarding the Park Board survey both result in limiting the public's ability to provide input and be fully engaged in discussions regarding the direction and future of their town.

Taken together, the contents of the e-mails and other public documents shared within this complaint have served to undermine the public's trust and reduce public confidence in local government, in contrast with the intent of Tenet 3 (Public Confidence) of the ICMA Code of Ethics.

We respectfully request a full review of the public records we are providing to you and a determination of whether or not these actions, comments and directions indeed violate the ICMA Code of Ethics. We care deeply about our community. We are very concerned by what seems to be a very dismissive attitude toward residents and some of our city's elected and appointed officials, and an unhealthy pattern of conduct that is injurious to our community and the city manager form of government.

Ohio auditors say Hudson city email shouldn't be used to discuss political campaigns

Next audit of Hudson finances will review email use.

HUDSON — The Auditor of State's Office told the Hudson city council president that if he is using his council email account to promote political campaigns, he should "cease and desist" from those activities "immediately."

Auditor of State Keith Faber and Chief Deputy Auditor Robert R. Hinkle issued that directive to City Council President Bill Wooldredge (at large) in an Aug. 28 letter.

"All information relative to this matter is being forwarded to [the auditor of state's] regional staff for review in the next regular [financial] audit of the [city]," wrote auditor of state officials. "This letter will also be forwarded to the Summit County prosecuting attorney for her awareness and consideration."

Wooldredge told the *Hub-Times*, "I've been advised by legal counsel not to say anything."

The letter was issued after Hudson Mayor Craig Shubert in July asked the auditor to investigate whether Wooldredge violated state law when using his council email account.

While noting they had not confirmed whether the allegations against Wooldredge were accurate, auditor of state officials told him that if the claims are true, he must stop the practices "immediately."

The auditor of state representatives wrote they were notified Wooldredge "may have inappropriately engaged in activities potentially in violation of Ohio law as well as city of Hudson policies in support of a political campaign."

"Information we have been provided suggests that that you are utilizing your city of Hudson email address and services to promote one or more campaigns for Hudson City Council," wrote auditor of state officials.

They noted state law prohibits individuals from using public money to benefit a candidate.

The complaint that Shubert sent to the auditor in July included 10 exhibits he collected from The Hudson Files website, which is publicizing emails sent by council members and other city officials.

Exhibits Shubert sent to the auditor included an email from Wooldredge to council candidate Nicole Kowalski telling her he would sign her nomination petition and donate to her campaign, an email string among Wooldredge, Kowalski and Nicole Davis where they set up a meeting to discuss Davis' plan to run for council, and an email string between Wooldredge and Davis where Wooldredge said he would help Davis with her campaign.

Concerns Related to Increased Traffic Generated by Phase II:

We knew increased traffic related to Phase II would be a concern to residents and it was one of the issues we studied very carefully early on. Although we've already made changes to Phase II to address this issue, we expect additional changes we make to the project based on May's vote and the community's input will reduce traffic levels even further.

Phase II aside, we all know there are times when traffic levels in downtown can be frustrating. That's why the smart signaling program we're about to launch is so important. We've looked at a number of systems other communities like Westlake and (second local example) have put in place. They've seen significant improvements in traffic flow with these systems and we hope to get the same type of results.

Our intent is to get started on the smart signaling program immediately and to have it all in place, with improved results particularly at chokepoints like 303 and 91, before Phase II is completed. CAN WE SAY THIS? There's more information on our website about this, but watch the Hub, because we're going to announce details of the program soon.

Concerns Related to the Density of Phase II:

Actually, we've already taken a hard look at that issue and have significantly reduced the density of Phase II. We had already completely eliminated the apartments before the May vote and reduced the overall residential footprint by 30 percent. The commercial space had been reduced by a third as well.

Based on the feedback we've gotten since the May vote, we may ask Testa Builders to reduce the project's density even further. Right now, Phase II density is only a percent or two more than some of the blocks in the historic district. That's the model residents have told us they want, and that's what we're aspiring to.

Concerns Related to the New Town Hall

We know some residents would like to use some of the Phase II site for a new town hall. We looked very hard at that question, but the numbers simply didn't work. It would cost taxpayers twice as much to build a new town hall downtown compared to the property we've purchased off of Hudson Drive. And, it wouldn't have the meeting and public space that building will have.

But more important, a town hall built on Phase II land would not generate any property tax for the city and wouldn't generate any income tax. Above everything else, we know Hudson's residents expect City Council and city government to be good stewards of the tax dollars they give us. The decision we made about the new town hall is the fiscally responsible decision.

Concerns Related to a Municipal Recreation Center

We know that some residents would have liked to see a recreation center built on the Phase II property. We looked at that question very carefully and decided for a number of reasons that it would not be a responsible use of the property. First, it would generate a lot of extra traffic downtown, which we know is a big concern. Macedonia's rec center has 150,000 visitors a year. That is a lot of cars moving through downtown. Second, a city-owned facility would not generate any tax revenue, while the residential units and offices planned for Phase II will.

Finally, there's a lot of competition for the community's fitness dollars. In addition to Life Center and Summa, we are seeing more and more boutique fitness facilities open in Hudson. If the city were to consider building a community recreation center, we would need to make sure it could operate competitively. The last thing we would want to do is build a center, then have to ask residents to support it with more taxes.

Concerns That Resident Input is Being Ignored

The numerous comments we received at our three work sessions and through email speak to how passionately people care about our community, how varied opinions are and how individuals frequently have views in direct opposition to one another. (If you haven't, we invite you to review those comments on our city website.)

We understand that and appreciate all the input. Now, we believe, it's our job to take those opinions into account and use them to help shape plans that also meet our responsibilities to be fiscally responsible and sensitive to Hudson's history. We have to make smart choices now that will help Hudson continue to be an attractive, thriving community next year and for years to come.

Concerns in General About Hudson City Government

I know it seems that a lot of things are happening in Hudson all at once. Ideally, we would have taken on projects a bit more slowly to help residents absorb all the change a little more gradually. The truth is, we are simply doing the most we can to position Hudson for the future. Things like broadband, a livable downtown for Millennials and Baby Boomers, a new town hall with space for residents to meet and class A office space for new tech companies are all designed to position Hudson for the future – not just five years from now, but 20 or 30 years from now. You've entrusted us to make sure the Hudson our children inherit is as wonderful as the Hudson we've all lived in. We take that responsibility very seriously.

Dennis.

When the park board consultant submitted their draft report, Frank, Jody and I all reviewed it and expressed our concern for the amount of programming questions in the draft. We also wanted the board to understand that a member of council brought up the issue of a rec center at a council session (I believe the last one in July) indicating that it sounds as if Council should look into this at some point since members of the public have raised the issue repeatedly. That brief discussion was followed up during one of the earlier August Council sessions and it was my impression from that discussion that Council wanted to discuss the issue further. At least Hal and Bill mentioned a citizen ad hoc group.

In following up with Bill as to when we should schedule this discussion, he felt sometime toward the end of the year after we got through the budget and other time sensitive issues. I took that as sometime later in November or early December.

I believe there was some park board member upset at our edits on the draft survey and I was told the park board wanted a meeting with Council. That's when I called Keith and suggested he discuss their concerns with their Council liaison who could relay the concerns to the body of Council. Shortly thereafter I informed you that Keith may be in touch on this matter. The next Friday morning Dan Williams told me he had been contacted by a park board member who expressed frustration on this matter. I told Dan that we felt programming did not belong in the survey as that area is currently under the purview of HCER.

We also discussed briefly if a survey were to be done by a citizen ad hoc group on a rec center, would it be better to combine surveys to avoid citizen survey fatigue. I believe all members of Council know there is a standing Friday morning meeting to review the agenda for the upcoming week before it gets published. I also believe members of Council know they can attend these sessions though we try to keep the attendance under a quorum.

As you have attended these meetings in the past, I'm sure you have participated in discussions during these meetings and I use the opportunity for input or suggestions on issues that may be coming up.

There was never any intention or direction for the park survey to stop. Frank's first point below was to keep moving forward with the development of the questions and survey tool. When it is ready we will know more if there are multiple opportunities to combine or consolidate various surveys if there is even a desire to have other surveys developed.

I believe there is some sensitivity on the park board due to the long delays and/or discussions on the skate park. So having another contentious issue so soon after that was unsettling. Again, my suggestion to the park board chair was to use their liaison for clarification and I'm glad they did. Jane

I gave my opinion to the park board Monday. Namely, that they should proceed with a survey that addresses the park system as it is currently constituted, but without any questions related to programming and a potential recreation center. I had advised them in the Spring that the survey should not include rec center related questions as council had been reluctant to initiate such a project again. And Tuesday, I reported on the park board meeting during the council comment section.

I have been curious what caused the turmoil among the park board members. I am finally digging out of the email pile and I think I understand what it was. It was the email below that Trent Wash sent to the park board, and me. It is self-explanatory, but it also shines a light a dynamic that has been alluded to on a number of occasions.

Note the comments that I have highlighted in red. Somehow a meeting of you and "some council members" became a full council directive to stop the survey. Further, perhaps as stated in the email, the council wishes to consider the rec center question, but I have not been a party to any meeting to discuss an approach in any detail.

There simply has not been any council mandate or direction on this survey, other than authorizing the survey expenditure. To make a statement to any board or citizen group on any subject as a council directive or decision when nothing of the sort has been made is destructive of council, the city and orderly proceedings.
