

We will then need to structure other questions that we feel pertain to our parks and the community in replacement of the deleted subjects that will best fit our vision of the final survey/Master Plan. Let me know if you have any questions.

Subject: Parks Survey information

Trent: Following a meeting with the City Manager and her meeting with Council Members this morning we have been asked to do the following regarding the Parks Community Survey portion of the master plan development:

- 1. Continue to develop the Parks Survey as you are.
- 2. Complete the refining of the questions as not to include any questions or references to parks programming or those items related to a potential indoor Community Recreation Center 3. Upon the Park Board's final draft of the document send it to me and you and I will discuss with the City Manager.
- 4. Upon agreement on the draft and the development of the final document we are to hold and table the document. City Council as you know wishes to address the idea of a potential Community Recreation Center utilizing some type of community survey. There will also be discussions moving into the fall of the year to perhaps develop and distribute a new Community and City Services Survey. Whichever is ultimately decided upon, the Parks Survey questions can be incorporated into a final survey document. I would envision that a comprehensive City Survey would be an RFP project within the Community Development Department. That said, it is feasible that the consultant that you and the Board have been working with could submit a proposal and continue its work with the City.

Please share this information with the Park Board Chair and the Park Board Members so they are fully informed of this change in plans.

Let me know if you have any questions and keep the group working towards a completed Parks Survey that is ready to add to a comprehensive document whatever that may look like.
