We have an important election coming up November 5<sup>th</sup>. All residents are encouraged to vote as the City of Hudson, while non-partisan, is facing a challenge from status-quo candidates who oppose growth of the City.

#### Recent City Accomplishments

- Continued good financial health, with an AAA bond rating and a robust fund balance.
- Council decided to reinvest in the City's future, by investing some of its 40% fund balance (higher than most other cities in the State of Ohio) in short-term initiatives that would generate revenues and start building back the reserve fund to 40%. In a few short years, the balance is back up to between 34% and 36%. The City invested in:
  - Downtown Phase II that will be paid for by the developer
  - Increasing the commercial/industrial economic base in Hudson Crossings, Connectivity Plan.
  - Repair of the roads, with more than a \$1 million added a year for the past two years.
  - Investing in a high-speed fiber internet network.
  - The new City Hall will have twice the space at nearly half the cost
  - City once again this year was awarded a Clean Audit Award
  - Many inspection services in-house, and is using engineering interns
  - An increase in communications through social media, a newsletter ...
  - Increase the number of grants awarded to the City to offset out-of-pocket costs

It is in our long term interest to support candidates who keep Hudson "in the lead" because the City remains so important to keeping our retirement community full and thus financially stable.

Dear Fellow Lakers:

I'm writing today to let you know of my strong support for your Ward 2 Councilwoman, Lisa Radigan. Lisa joined Council in February, and I have been very impressed by her ability to understand and assess complex issues quickly. She is already advocating effectively for the issues that concern her constituents, and she brings a fresh perspective and energy to Council that I greatly appreciate.

Lisa is the Chief Ethics and Compliance Officer and Assistant Corporate Secretary at Diebold Nixdorf where she oversees the company's global ethics and compliance program, manages regulatory and corporate governance issues, and is responsible for a team of nearly 30 people worldwide. Prior to joining Diebold, she was an attorney at Jones Day. She has spent her career devoted to helping companies and individuals engage in business transparently while also working collaboratively to identify ways to progress strategic objectives. She brings that same dedication to transparency, collaboration, and progress to Council.

From the time she joined Council, Lisa has been proactive in advancing projects important for her constituents. She spearheaded the effort to implement a warning signal at the Hines Hill rail crossing to warn drivers of stopped trains (it will be installed by the end of September). She has also been instrumental in progressing the Phase 2 project. In addition, she has provided great suggestions for ways in which the City can better communicate with residents about projects and initiatives that impact them. I am excited to see what she can do if she is given more time.

While her accomplishments are impressive, she is also extremely dedicated to her community and to her family. Most importantly, she is mom to 6-year-old Milo (a first grader at Evamere) and 3-year-old Parker. She and her husband Christian have made Hudson their home and are raising their family here. Her only agenda is ensuring what is best for Hudson in the long term.

While I do not yet live in her Ward, I would vote for her if I did – **and I encourage you to vote for her on or before November 5**. She has my strong support and I sincerely hope she can continue to bring her energy, talent, and strong sense of purpose to Council.
